Sub:- Affiliated College – Grant of extension of provisional affiliation to **Matrusri Institute of P.G.Studies**, Saidabad, Hyderabad, to offer **MBA Course** for the academic year **2011-2012**– Orders - Issued.

Ref:- G.O.Rt.No.603/HE (EC.2) Dept., Govt. of A.P., dated 18.8.2010.

Based on the approval of the AICTE, permission from the Government of Andhra Pradesh and on the recommendations of the University Inspection Committee, sanction is hereby accorded for grant of extension of provisional affiliation to **Matrusri Institute of P.G.Studies**, 16-1-486, Saidabad, Hyderabad, to offer **MBA Course** with an intake of **(180)** for the academic year **2011-2012**. However, the College has to fulfill the following conditions / deficiencies:-

1. Appointment of a Principal, two Professors and four Associate Professors through duly constituted selection committee.
Further, the College has to ensure that the Faculty cadre ratio of 1:2:4 (i.e. one Professor, two Associate Professors and four Lecturers) by maintaining faculty student ratio of 1:15 on the approved intake at any time.
2. Prescribed books of 1500 volumes be procured for the year 2011-2012.
3. In addition to the existing journals ⁷ seven more National Journals to be subscribed for the year 2011-2012.
4. Teaching Diaries and Students attendance registers to be maintained properly.
5. Salaries to be paid through Account Payee Cheques.
6. Three Governing Body Meetings associating University nominee to be conducted in a year.
7. The Faculty to be deputed for Refresher Courses/Orientation Programmes/Faculty Development Programmes conducted by Osmania University/Other Institutions.

The compliance report on the fulfillment of deficiencies/conditions pointed out by the Inspection Committee along with the documentary evidence be submitted on or before **31.12.2011** in the following proforma, through the University representative on the Governing Body of the College.
