Sub:- Affiliated College – Grant of extension of provisional affiliation to **Matrusri Institute of P.G.Studies**, Saidabad, Hyderabad, to offer **MBA Course** for the academic year **2014-2015**– Orders - Issued.

Based on the approval of the AICTE, permission from the Government of Telangana and on the recommendations of the University Inspection Committee, sanction is hereby accorded for grant of extension of provisional affiliation to **Matrusri Institute of P.G.Studies**, 16-1-486, Saidabad, Hyderabad, to offer **MBA Course** with an intake of **(120)** for the academic year **2014-2015**. However, the College has to fulfill the following conditions / deficiencies:-

1. The College has to ensure that the faculty student ratio of 1:15 and faculty cadre ratio of 1:2:4 is maintained by appointing one Professor, two Associate Professors and four Lecturers for an sanctioned intake of 60 students at any time.
2. The College has to obtain the University approval for all the teachers appointed through duly constituted selection committee up to the academic year 2014-15.
3. Prescribed books of 1000 volumes to be procured for the year 2013-2014.
4. Four International journals and twenty National Journals to be subscribed for the year 2014-2015.
5. Ten Computers with internet facility to be provided in the Library.
6. Teaching Diaries and Students attendance registers to be maintained properly.
7. Salaries to be paid through Account Payee Cheques.
8. Three Governing Body Meetings associating University nominee to be conducted in a year.
9. The Faculty to be deputed for Refresher Courses/Orientation Programmes/Faculty Development Programmes conducted by Osmania University/Other Institutions.

NOTE: As per the sanctioned intake of (120) the College has to appoint one Principal, Two Professors, Four Associate Professors and Eight Lecturers are required. As such, if any short fall in the above cadre, the college has to recruit them immediately through duly constituted selection committee. Inspection will be conducted to the College at any time, if necessary.

You are, therefore, directed to submit the compliance report on the fulfillment of the above deficiencies/conditions in the following format along with the documentary evidence to reach this office **within one month** from the date of issue of these orders, through the University representative on the Governing Body of the College.
