Sub:- Affiliated Colleges – Grant of extension of provisional affiliation to Matrusri Institute of P.G. Studies, Saidabad, Hyderabad to offer **MBA Course** for the academic year **2017-2018** – Orders – Issued.

Based on the approval of the AICTE and on the recommendations of the University Inspection Committee, sanction is hereby accorded for grant of extension of provisional affiliation to Matrusri Institute of P.G. Studies, Saidabad, Hyderabad to offer **MBA Course** with an intake of **(60)** for the academic year **2017-2018**.

The above extension of provisional affiliation orders is sanctioned, subject to fulfillment of the conditions / deficiencies pointed out by the University Inspection Committee, AICTE, Government of Telangana and general rules of affiliation.

- 1.The College has to ensure that the faculty student ratio of 1:15 and faculty cadre ratio of 1:2:6 is maintained by appointing one Professor, two Associate Professors and four Assistant Professors as per AICTE/OU norms for an sanctioned intake of 60 students at any time.
- 2.Prescribed books of 500 volumes to be procured for the year 2017-2018.
- 3.Two International journals and Ten National Journals to be subscribed for the year 2017-2018
- 4.Five Computers with internet facility to be provided in the Library.
- 5.Teaching Diaries and Students attendance registers to be maintained properly.
- 6.Salaries to be paid through Account Payee Cheques/Bank.
- 7.Three Governing Body Meetings associating University nominee to be conducted in a year.
- 8.The Faculty to be deputed for Refresher Courses/Orientation Programmes/Faculty Development Programmes conducted by Osmania University/Other Institutions.

NOTE: As per the sanctioned intake at S.No.1 the College has to appoint one Principal, required number of Professors, Associate Professors and Assistant Professors. As such, if any short fall in the above cadre, the college has to recruit them immediately through duly constituted selection committee as per AICTE and OU norms. Surprise inspection may be conducted by the University at any time.


Further, the conditions / deficiencies pointed out by the University Inspection Committee:

- 1.Principal to be appointed through a duly constituted Selection Committee.
- 2.Prescribed books worth Rs:50,000/- to be procured.
- 3.(2) International and (10) National Journals to be procured. The college is also advised to go for-journals..
